

## YOUTH-IN-CARE TUITION BURSARY APPLICATION FORM

Red River College is committed to removing the financial barriers to education for Youth-In-Care. Twenty full tuition bursaries are available to Youth in Care each year. Youth must meet College program admission requirements and recommended by their Authority.

**Eligibility:**

You may be eligible to apply for the Tuition Bursary if you are a current or former youth-in-care, regardless of legal status, and meet the following criteria:

- ✓ Have applied to a full-time program at Red River College or have been given an offer of admission to the College
- ✓ Over the age of 18 or turning 18 during the academic year

**How to Apply:**

In order to be considered for this program, please contact the Authority listed below that is most appropriate for you. Each Authority will nominate candidates in their area and forward them to the College for final selection. Notification if you have been selected for the bursary will take place in June/July.

Provide the completed application form and your offer letter or application status documentation from Red River College to your Authority contact.

## ENROLMENT SERVICES

### Consent to Release Applicant/Student Information

#### Freedom of Information and Protection of Privacy Act (FIPPA)

The same law that gives caregivers and parents access to and control over a child's educational records during elementary and high school transfers ownership of the records to the student at the college level.

College students are considered responsible adults and are allowed to determine who will receive information about them and their studies. Under this law, confidential student information cannot be provided to anyone other than the student unless the students has provided written consent to the College or the student is a dependent who is 17 years of age or younger.
